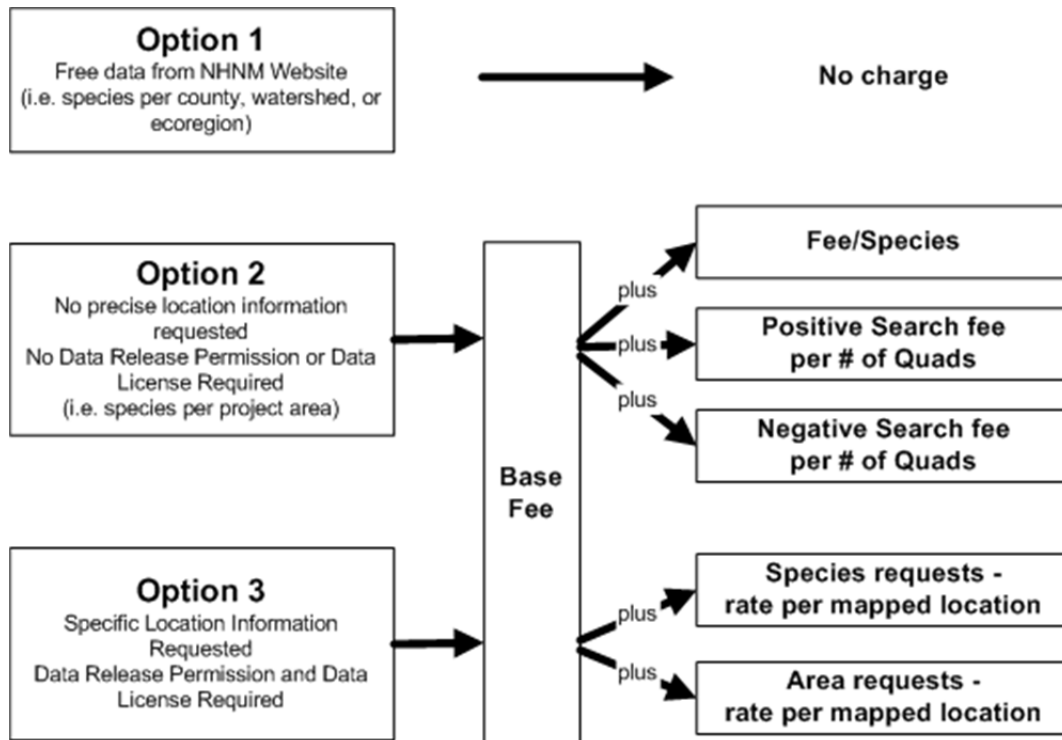




NHNM Information Request Rate Structure (effective 12/17/2012):



Option 1 – Using data from NHNM Website

Data is available to the public, free of charge, at <http://nhnm.unm.edu>. Free data includes:

- lists of species per county, watershed, or ecoregion
- lists of species NHNM tracks
- lists of counties per species

Option 2 – no spatial data – no Data License Agreement necessary

Option 2 data requests do not include spatial data and, therefore, a Data License Agreement is not required. Requests are usually for species in an area (i.e a project area). A search of our databases, consultation with our biologists where appropriate, and a response letter will be provided for a base fee (\$105) PLUS fees per area (see below).

USGS 7.5min quadrangle search fees that vary depending on whether pertinent data exist (\$115/quad) or do not exist (\$55/quad) for each quad within the client's geographic area of interest. A 15% discount will be applied to the quad search fees for data requests submitted by non-profit clients and students.

A. Requests by Geographic Area (not entire state)

For-Profit

	Rates/Fees
Base Fee	\$105.00
PLUS price per square mile searched	+ \$5/square mile
OR price per USGS 7.5' quad	\$115/quad with data, \$55/quad without data

Non-Profits and Students receive a 15% discount

B. Requests by Polygon for Entire State

Polygons can be USGS 7.5 min. quads, HUC 10 watershed polygons, a custom grid, etc.

For-Profit

	Rates/Fees
Base Fee	\$105.00
PLUS price per polygon for list of species per polygon	\$3/polygon, grid cell, or quad
PLUS price per polygon for summary information per quad (i.e. number of federally listed species per quad)	\$1.50/ polygon, grid cell, or quad

Non-Profits and Students receive a 15% discount

Option 3 – includes spatial data –requires Data License Agreement

Option 3 data requests include spatial data and require signature of a Data License Agreement. Requests may be received by species or by geographic area. Spatial data and associated tabular reports for requests by species are provided for a base fee (\$350) PLUS a flat rate based on the category of mapped locations requested by the client. Spatial data and associated tabular reports for request by geographic area are provided for a base fee (\$350) PLUS a fee per mapped location requested by the client (based on Optioned fee schedule). A 15% discount will be applied to data requests submitted by non-profit clients and students.

Requests by Mapped Locations or Geographic Area

For-Profit

Base Fee \$350

PLUS Fees per Mapped Location + Tiered \$/ML

Tier	# Mapped Locations	\$/ML
First 100	0 – 100	\$6.00
Next 400	101 – 500	\$5.00
Next 500	501 – 1,000	\$4.00
Next 4,000	1,001 – 5,000	\$3.00
Next 5,000	5,001 – 10,000	\$2.50
Next 5,000	10,001 – 15,000	\$2.00
Next 5,000	15,001 – 20,000	\$1.50
Next 5,000	Over 20,000	\$1.00

Example calculation for 685 mapped locations: $\$350.00 + (100 * \$6.00) + (400 * \$5.00) + (185 * \$4.00) = \$3,690$

Non-Profits and Students receive a 15% discount
